## CONDITIONS OF ENTRY

1. For entries in the judged contest, this Entry Form and NMRA form #902, Judges' Score Sheet, must be completed, one pair of forms for each entry.
2. Supplemental information, including plans, photos and other supporting documentation may be submitted. This should be organized in order by judging factor (Construction, Detail, Conformity, Finish & Lettering, and Scratch-built). However, judges are under no obligation to review this material, and the Contest Chairman may limit this information.
3. The Contest Chairman reserves the right to determine how to display entries. Removal of entries from the Contest Area without approval of the Contest Chairman and presentation of the claim check is prohibited.
4. After filling out this Entry Form and the Judge's Score Sheet if applicable, return both to the Contest Staff who will provide an Entry no. for the Entry Form, Judges Scoring Sheet, Claim Check, and Entry Identification Tag. Place entry with Identification Tag attached in the designated location. Retain the Claim Check, which must be signed and presented to pick up the entry at the end of the contest.
5. I hereby certify that all judged contest entries are entirely my/our own work or that the original exposure was made by me. I also hereby release the Convention and all persons connected with the contest from any liability due to damage or to loss of the entry.

INSTRUCTIONS FOR ENTRANTS  
JUDGED, FAVORITE MODEL AND PHOTO CONTESTS**

**CHECK IN:**

1. Fully complete an entry form for each entry! Extra entry forms and instructions will be available or you can make copies. There are ten (10) Favorite Model categories and four (4) Photo Categories, and a new “Display” category. A parallel contest for Scratch Built, and Kit Built models which conforms to NMRA Contest Practice is also available. All models entered will be voted on as a Favorite Model, and those entered in the Judged Contest will, of course, be given appropriate points by certified NMRA Judges. Note that you must be an NMRA member, and your entry must be Scratch Built or Kit Built in order to enter the Judged Contest. The new, “Display” category will not receive votes in the Favorite Model Contest, but may, at the discretion of the NMRA Judges, receive achievement points. Entrants in the Judged Contest must also complete NMRA Form #902, NMRA NATIONAL CONTEST JUDGING FORM.

2. Entrants will be given an Entry Number and a Claim Check by the Contest Monitor. This Claim Check will be required in order to reclaim the entry. (Please do not write on, fold or damage the Claim Check.) Note that entries are to be identified by number only. Items are entered at the sole risk of the owner; The O Scale National Convention does not indemnify owners against loss or damage.

3. The Contest Monitor will instruct you as to where to place your entry.

4. Entries will be received beginning at 8:00 AM on Thursday. Descriptive information about the entry may be placed by the entry but will be limited in size to 8-1/2” X 11”.

5. Viewing is to take place between 10:00 AM and 5:00 PM on Thursday, and 9:00 AM to 12:00 Noon on Friday, Balloting is to start at 10:00 AM and CLOSE at 12:00 Noon on Friday. Contest winners will be announced at the Banquet on Friday Evening, and viewing of all entrants, including winners, will take place from 9:00 AM to 12 Noon on Saturday.

**CHECK OUT:**

Entries will be checked out only to persons holding a valid Claim Check. ALL entries are to be picked up after 12:00 PM on Saturday, and MUST be picked up by 3:00 PM.
